## LETTER FROM SECRETARY OF EDUCATION ARNE DUNCAN TO THE GOVERNORS

Arne Duncan, April 1, 2009

This letter focuses only on the \$48.6 billion portion of the State Fiscal Stabilization Fund intended to help states balance their budgets. Even though it does not address issues related to the Secretary's discretionary State Incentive Grants, we believe its provisos will offer guidance in the distribution of those funds too. This is because the proposed metrics related to the four assurances it discusses—on (a) teacher effectiveness and qualifications, (b) high standards and rigorous assessments, (c) support, interventions and achievement in schools that need it most, and (d) better information for educators and the public—must also be addressed in state applications for the incentive funds. The Innovation Fund has a slightly different, but related, set of usage criteria.
